- 1. Call To Order Chair Alexander called the meeting to order at 7:14 p.m.
- 2. Opening Prayer Fr. Brunet opened the meeting with a prayer.

Elaine Carr, teacher and Artist in Residence for the Catholic Education Centre's Public Art Project, was present to provide an overview of an arts project began last spring by grade one students at St. Pius X Catholic Elementary School. Students began exploring endangered species of the bioregion for a special arts sculpture project to be placed at the Catholic Education Centre in Windsor and became so involved with their adopted species that they continued researching, writing poetry and creating a big drawing showing their endangered species in habitats. Moved by Trustee Soulliere and seconded by Trustee Janisse that the Board approve payment of the Ontario Association of Parents in Catholic Education (OAPCE) 2010 annual membership fees for 41 elementary school councils and 8 secondary school councils in the amount of \$68.00 per school (\$3,332.00 total) to be funded from the Membership Fees budget line (000-33-701000-6-000-0). *Carried*.

d. Report: Harmonization of Full-Day, Alternate Day Kindergarten

Trustee Porcellini moved that the Board defer the Harmonization of Full-Day, Alternate Day Kindergarten report be deferred to the December 8, 2009 meeting so that additional information can be provided to parents. *No seconder*.

Discussion was held on provisions for siblings to attend school on the same schedule, the potential impact on child care providers, and on communicating the implementation plan to parents. Administration will keep trustees apprised of the implementation process and communication plans to the school community.

Moved by Trustee Janisse and seconded by Trustee DiMenna that the Board approve the transition of the current delivery model for the Junior and Senior Kindergarten program in the city elementary schools to a full-day, alternate-day model by September 2010. *Carried.*

e. Report: Follow-up to East Windsor School Accommodation Review - St. Bernard Catholic Elementary School - Secondary Feeder School Options

Moved by Trustee Porcellini and seconded by Trustee Janisse that the Board approve, beginning in the 2010-2011 school year, the option for students of St. Bernard Catholic Elementary School (Windsor) to attend either Catholic Central High School or F.J. Brennan Catholic High School. Carried.

• Trustee Courtney: "At the next regularly scheduled meeting, of the Board, I will move or cause to be moved that early in January, Administration begin gathering information for a report to the Board on the issuing of picture I.D. cards to all board employees, including occasional teachers. Surveys would be sent out to the Executive of all employee groups and School Councils as well as parents. Current practices by other Boards as well as organizations in this area would also be included. The report would be due by the first meeting in March."

15. Remarks and Announcements:

- a. Chairperson Alexander commented on his attendance at the November 17 Commissioning Ceremony for school council chairs and commended the organizers on the success of the event.
- b. Director of Education Berthiaume provided comment on recent activities supporting the Board's strategic priorities faith development and student achievement; community engagement and partnership activities; and, recent employee recognition events. Director Berthiaume reported that the next year's Catholic Principals' Council of Ontario (CPCO) Annual Conference will be hosted by the Windsor Essex Principals and Vice Principals Association.
- c. Board Chaplain Fr. Brunet No comments this evening.

16. Remarks/Questions by Trustees

- Trustee Soulliere provided comment on the deteriorating condition of St. Bernard Catholic School (Windsor) and the fact that the Board's prohibitive to repair funding application to the Ministry of Education has remained outstanding for the past four years while the coterminous board has received Ministry approved funding for several capital improvements and new school projects. Trustee Soulliere expressed concern that the apparent lack of action by senior government officials leaves the impression Catholic education has taken a back seat in the publicly funded education system. Trustee Soulliere called for a meeting with Ontario Finance Minister and Windsor-Tecumseh MPP Dwight Duncan, who represents the riding where St. Bernard school is located, in order to move the funding application forward and proceed with the process of replacing the facility. Trustee Soulliere further asked that administration conduct a review of the facility to confirm there are no imminent safety concerns. Trustee Soulliere provided comment on the recent announcement on the provincial full-day early learning for four and five year olds. Trustee Soulliere asked that Ministry officials be contacted to determine why the funding provided to this Board and the coterminous Board is not allotted in proportion to the ratio of students enrolled in each system as the inequity of pupil places allotted for the Catholic system places negatively impacts the Board.
- Trustee Porcellini indicated her support of Trustee Soulliere's concerns regarding St. Bernard's prohibitive to repair application and the allotment of the Early Learning Program pupil place allotments. Trustee Porcellini briefly reported that the French Immersion Advisory Committee met November 23 and extended her appreciate to the Council of Ontario Directors of Education for their letter to the Ministry of Education concerning the impact of the many Ministry initiatives coming forward.
- Trustee Courtney indicated her support of Trustee Soulliere's concerns regarding St. Bernard's prohibitive to repair application and the allotment of the Early Learning Program classroom allotments.
