 - a. Delegation Regarding Items <u>Not</u> on the Agenda
 - Patricia Holland, CUPE 1358 President read a letter prepared by Suzanne Hopkins, CUPE National Rep and voiced CUPE 1358 members concerns over the recent layoffs. Renee Cantarutti, board speech pathologist spoke about the reduction of two full-time equivalent speech pathologist and its affect on the students. Monique Evans, board social worker spoke about the recent layoffs and the importance of social worker's role of establishing trust with the students.
 - ii) Jolene LaRue, parent from W.J. Langlois, school spoke about the benefits of Full Day Early Learning quoting various sources.
 - iii) Jordanne Bachmeier and Emily Peters read primary student comments; Brayden Bachmeier and Ryan Sabourin read junior student comments; Tomas and Marisa Buchan read senior student comments from the book "What does Langlois mean to Me?
 - iv) Daina Bachmeier, parent from W.J. Langlois, discussed the benefits of open concept in relation to everyday life situations.

- v) Heather Marion, W.J. Langlois Catholic Elementary school parent to spoke about the strengths of W.J. Langlois school citing ample natural light, air conditioning, parking, Public library, track, and full day early learning. Ms. Marion would prefer students from both schools to begin in September at W.J. Langlois.
- vi) Kaylee Charron, former student of W.J. Langlois mentioned she has experienced both open concept and traditional learning and believes there is not a difference between the two. She also mentioned for her it was easier to deal with the open concept distractions then close classroom distractions.
- vii) Nancy MacNeil, parent from W.J. Langlois school encouraged trustees to accept Director Picard's Fontainebleau recommendations, commented on the benefits of the school and community, and presented the Board with a petition. Ms. MacNeil also read a letter from Friends of Fontainbleau President Ron Marshall also requesting W.J. Langlois to remain open. Jenna MacNeil, student from W.J. Langlois school mentioned qualities of W.J. Langlois including Drama presentations, track practices and use of the Public Library.
- viii) Donna Debergh and Jessica Daidone, students from W.J. Langlois indicated open concept is a quiet functional learning environment where they have developed concentration skills, respect for others and maintain straight A averages.
 Ms. Debergh emphasized her success will be based on choice and not open concept learning.
- ix) Candice Szaniszlo and Joseph Yousif, students from W.J. Langlois school to speak about their safe schools team and comparing the board and school climate survey results indicating more than half of the grade 6 Board/School climate survey questions, W.J. Langlois ranked higher than Board average.
- x) Huda Kreto, parent from W.J. Langlois school and speaking on behalf of former student Sara Guzzetti, read a letter prepared by Sara Guzzetti who complimented the staff at W.J. Langlois on their teaching adaptabilities especially with students new to Canada.
- xi) Monica Klien-Szaniszlo, parent from W.J. Langlois presented trustees with a letter from the Pastor at Ambassador Community Church permitting parents to park in the church parking lot.
- xii) Catherine Johnson, parent from W.J. Langlois encouraged St. Alexander parents to review all aspects of W.J. Langlois school, not only the open concept. Ms. Johnson provided examples of recent renovations at W.J. Langlois and suggested to amend the Director's recommendations to relocate the St. Alexander school to W.J. Langlois September 2012 and to develop a Integration Committee to form a strong community.
