Employee Development and Student Achievement Initiatives: The following workshops are scheduled during the month of March: Attendance Management Training; System Implementation and Monitoring; Primary and Junior sessions; EQAO sessions for teachers and principals; and a principal mentoring session with lawyer Eric Rohrer. Community Engagement and Partnerships: The Accommodation Review Committee public meetings, where the public are welcome to provide input are scheduled for:

- ➤ Riverside area: Tuesday, April 15 at 6:00 pm at F.J.Brennan Catholic High School
