1. Call To Order – Chair Holland called the meeting to order at 7:01 pm.

Chair Holland assured members of the audience that the Board meeting was designed specifically to receive public input on Administration's Accommodation Review Recommendations for the Amherstburg Area. Chair Holland recognized Catholic School Advisory Council Chairpersons and thanked the principals, vice principals, custodians and students for their assistance in preparing for this evenings meeting.

Chair Holland outlined the delegation process and time limit and also mentioned Trustees and senior administration will remain after the meeting to speak to members of the community.

- 2. Opening Prayer Fr. Brunet opened the meeting with a prayer.
- 3. Recording of Attendance All trustees are present. Student Trustee Bowers sent his regrets due to a prior commitment.
- 4. Approval of Agenda No amendments this evening.

Moved by Trustee DiMenna and seconded by Trustee Mastromattei that the February 29, 2016 Trustee Delegation meeting agenda be approved as distributed. *Carried* 

- 5. Disclosure of Interest Pursuant to the Municipal Conflict of Interest Act.: *None*
- 6. Delegations:
  - a. Frank Cleminson, Parent of children attending Stella Maris Catholic Elementary School to speak to start times, portables and total value to update the school.

Mr. Cleminson thanked Trustees for the opportunity to speak and stated his main focus is on the students' needs and to find the best solution should Trustees decide to close St. Bernard school.

Mr. Cleminson requested the following information from administration:

- Will the current start time at Stella Maris school remain the same for September 2016?
- Location of portables and anticipated duration?
- Expand intramural and team sports.
- Savings due to consolidation be reinvested in student needs (examples: new technology, smart boards, larger computer room).
- b. John Miceli, Community Member and Chief Administrative Officer for the Town of Amherstburg to present the Town of Amherstburg's position on school closures.

As per Board By-Law 3:09, the Board waived the 5 minute timeline required of delegations, and by resolution extended Delegation John Miceli's time limit.

Moved by Trustee Alexander and seconded by Trustee Mastromattei that the Board waive Delegation John Miceli's five minute time limit in order for Mr. Miceli to complete his presentation. *Carried* 

On behalf of the Town of Amherstburg, Mr. Miceli questioned the Board's rationale in the Final Staff recommendation to consolidate St. Bernard to Stella Maris. Mr. Miceli provided the following perceived challenges in the areas of:

- Transportation, bus bays and increased travel time;
- The missed opportunity to utilize a 30 acre municipal park across from St. Bernard;
- St. Bernard is more centrally located in the municipality and the primary settlement area, thus minimizing the impact on municipal road infrastructure and better equipped to handle the Town's future growth patterns;
- The Town receives parking complaints on the streets surrounding Stella Maris;
- Limited options for site expansions at Stella Maris, specifically as it relates to the

- addition of permanent classrooms;
- Smaller parking area, and smaller gymnasium at Stella Maris as well as limited opportunities for on-site and on-street parking;
- Future growth in the primary settlement area of the municipality is divided fairly evenly between the north and the south. However, due to infrastructure challenges, the south is better positioned for growth;
- The Town has major developments in the south which include Hunt Club Creek Subdivision (draft plan approved) at 800 homes and Smith Subdivision (preliminary planning phases) with 600 homes;
- Stella Maris located in the "Fraserville Area" under the Town's Nuisance Mosquito Program.

Director Picard provided the community with administration's rationale for the final staff recommendations for the Amherstburg area.

Trustees requested the following data to be supplemented in the final staff recommendation:

- What are the potential savings by installing portables at Stella Maris as opposed to students remaining at St. Bernard until construction of classrooms are completed.
- Transportation:
  - Majority of St. Bernard students will be bussed. How will that financially impact the Board?
  - > Address Bus bay access.
  - After school programs/sports Provide student transportation home.
- Address additional parking.
- Will the Ontario Early Learning Years Program at St. Bernard move to Stella Maris?

Moved by Costante and seconded by Mastromattei that the Board receive as information the Final Staff Report on the accommodation review study for the Amherstburg area, including St. Bernard and Stella Maris Catholic Elementary Schools; and

That the Board receive public input concerning the Final Staff Report, including the final recommendation presented by Board Administration as follows:

That effective September 2016, the St. Bernard Catholic Elementary School Community be consolidated with the Stella Maris Catholic School Community at the Stella Maris site, with students to be accommodated in the short term through the use of portables, as may be required; and

That the Board apply to the Ministry of Education through the School Consolidation Capital (SCC) Program for funding for the construction of an addition and renovations, as may be required, to support the consolidation at Stella Maris or, if failing to obtain SCC funding, a further report be submitted to the Board regarding alternatives; and

That effective June 2016, St. Bernard Catholic Elementary School be closed and deemed surplus to the Board's future needs, pursuant to Section 194 (3) (a) of the Education Act. *Carried*
