Chair Holland welcomed members in the audience and delegations. Chair Holland thanked Constable Danby and Constable Armstrong and Paladin Security for assisting with this evening's meeting.

- 7. Delegations:
 - a. Don Ouellette, Parent of Holy Names Catholic High School students to speak to fairness of secondary school busing.

Addressing fairness and equity, Mr. Ouellette suggested charge every bus user in the district of any grade a fee to ride a bus to school. This fee would be based on the difference of the total cost of busing minus the budget supplied by the Ministry divided by all the users of the bus system. If the Board wishes to restrict the paying users to secondary only, that too would be acceptable.

b. Raymond Hoang, Community Member would like to give support to the motion and suggest the school board make the bus pass a part of the registration fees.

Mr. Hoang suggested, similar to a student's education, busing should be a right and not a privilege.
