The Response to Intervention (RTI) is a three tiered service delivery system designed to assist students across curriculum and special education needs involving both math and reading.

h. Report: 2010 Temporary Borrowing Resolution - Annual Expenditures

Trustees received a report indicating that a Temporary Borrowing Resolution is approved annually authorizing a limit that the Board may borrow to finance the calendar year's expenditure. The short-term loan is required to bridge finance the Board's capital expenditures that will ultimately be debentured and finance operations when expenses exceed revenues, a situation that occurs at the end of every calendar quarter due to the time lag in receiving the tax levy payments from municipalities.

Moved by Trustee Soulliere and seconded by Trustee Holland that the Board approve the 2010 Temporary Borrowing Resolution (deemed to be read three times) authorizing the Board to borrow up to \$78,600,000 to meet, until current revenues are collected, the current expenditures of the Board for 2010. *Carried*.

2010 TEMPORARY BORROWING RESOLUTION - ANNUAL EXPENDITURES

WHEREAS the Windsor-Essex Catholic District School Board (the "Board") considers it necessary to borrow the amount of up to \$78,600,000 to meet, until current revenues are collected, the current expenditures of the Board for 2010.

AND WHEREAS the total amount borrowed pursuant to this Resolution together with the total of any similar borrowing is not to exceed the uncollected balance of estimated revenues of the Board.

THEREFORE, BE IT RESOLVED THAT

1. The Chairperson, Vice-Chairperson or Secretary-Treasurer of the Board are hereby authorized on behalf of the Board to borrow from time-to-time by way of Promissory Note a sum or sums

not exceeding the aggregate \$78,600,000 to meet the current expenditures of the Board until the current revenues have been received and to give on behalf of the Board a Promissory note or notes under the corporate seal of the Board signed by the Chairperson or Vice-Chairperson of the Board and the Secretary-Treasurer for the monies borrowed hereunder;

Provided, however, that the interest and any other charges connected therewith do not exceed the interest that would be payable at the prime lending rate on the date of borrowing of banks listed in Schedule 1 to the Bank Act plus 100 basis points.

- 2. The Secretary-Treasurer of the Board is hereby authorized and directed to apply in payment of all sums borrowed as aforesaid, together with interest thereon, all monies compromising the current revenues of the Board hereafter received.
- 3. The Secretary-Treasurer of the Board is hereby authorized and directed to deliver to the bank from time-to-time upon request a statement showing the total amount of unpaid previous borrowings of the Board for current expenditures together with debt charges, if any, and also the uncollected balance of the estimated revenues for the current year or, where the estimates have not been adopted, the estimated revenues of the previous year less any current revenues already collected.
- i. Report: 2010 Temporary Borrowing Resolution Permanent Improvements

Trustees received a report indicating that a separate resolution is required to segregate the capital portion of the loans in the amount of \$49,000,000 to bridge financing until a debenture is issued.

Moved by Trustee Janisse and seconded by Trustee DiMenna that the Board approve the 2010 Temporary Borrowing Resolution – Permanent Improvements (deemed to be read three times) authorizing the Board to borrow \$49,000,000 to bridge finance the permanent improvements as detailed in Schedule A of the Resolution. *Carried*.

2010 TEMPORARY BORROWING RESOLUTION - PERMANENT IMPROVEMENTS

WHEREAS the Windsor-Essex Catholic District School Board (the "Board") is permitted to borrow money pursuant to the provisions of Section 247 of the Education Act (the "Act") for the raising of funds to finance certain permanent improvements as more particularly described in this Resolution.

AND WHEREAS:

- A. The Board has authorized the permanent improvements as detailed in Schedule "A" attached to this Resolution:
- B. The Board wishes to apply to the Canadian Imperial Bank of Commerce ("CIBC") for a capital loan for the purpose of financing the permanent improvements;
- C. The total cost of the permanent improvements is within the Board's Debt and Financial Obligation Limit as established by the Ministry of Education and Training.

THEREFORE, BE IT RESOLVED THAT:

- 1. The Chairperson, Vice-Chairperson or Secretary-Treasurer of the Board are hereby authorized on behalf of the Board to borrow \$49,000,000 for permanent improvements in accordance with the Act, plus interest at a rate to be agreed upon from time to time with CIBC.
- 2. The Chairperson, Vice-Chairperson or Secretary-Treasurer of the Board are hereby authorized for and on behalf of the Board to execute and deliver all such other documents and to do such other acts and things as may be necessary to give full effect to the Resolution.

SYNOPSIS: Draft Policies ST: 05 Student Discipline Policy and SC: 18 Bullying Prevention and Intervention amend existing Board Policies ST: 05 and SC: 18 respectively, and are recommended for approval in principle.

BACKGROUND COMMENTS:

<u>Proposed Changes to Existing Policy/Procedure</u>: The Policy Working Subcommittee proposes the following changes to existing policy:

- Draft Amended Policy ST: 05 Student Discipline Policy to replace existing Policy ST: 05 Student Discipline Policy
- Draft Amended Policy SC: 18 Bullying Prevention and Intervention to replace existing SC: 18 Bullying Prevention and Intervention

<u>Source and Rationale for the Proposals</u>: The existing Board Policies were first approved by the Board on January 29, 2008. Draft amended Policy ST: 05 Student Discipline Policy incorporates recent amendments made to the Education Act (re: *Keeping Our Kids Safe at School Act, 2009*) and fulfills the directives set out within the Ministry's Policy/Program Memorandum No. 145, as revised October 19, 2009. Draft amended Policy SC: 18 Bullying

Prevention was prepared after consideration of PPM 144 Bullying Prevention and Intervention, as revised October 19, 2009. Both policies were reviewed by a Policy Working Subcommittee. Out of that review, the Subcommittee proposes the highlighted amendments noted in the attached draft policies that are intended to ensure compliance with regulations and ministry guidelines respecting student behaviour, discipline and safety, and, bullying prevention and intervention.

Results of Public Consultation Process: On December 18, 2009, the draft policies and supporting procedure were forwarded to principals and vice principals, with a request to forward to school council chairs and staff for their suggestions and comments. The drafts were also forwarded to union and association representatives, trustees, and posted to the Board's website to receive feedback and input.

The Policy Working Subcommittee considered feedback received and the recommendations of the Ontario Education Services Corporation, arising out of their consultation with the Ontario Human Rights Commission, in reviewing the draft policy as posted for feedback on the Board's web site, and has added wording to sections 3.17 and 3.18 of Policy ST: 05 (as highlighted in underlining) for clarity and comprehensiveness.

<u>Impact On Other Policies and Procedures</u>: The draft amended policy is consistent with existing board policy and procedure.

<u>Timetable For Implementing Policy and Procedure</u>: The legislated amendments take effect February 1, 2010. The policy shall be implemented upon final approval.

Benefits of the Policy Proposals: The further development of these policies reinforces the Board's belief that providing students with an opportunity to learn and develop in a safe and respectful community is a shared responsibility in which the board and schools play an important role, and acknowledges the Board's commitment to building and sustaining a positive school environment for all students in order to support their education and reach their full potential.

Risks of Policy Direction and Mitigation Strategies: - N/A

<u>Impact on Stakeholders and Plan For Communicating the Policies</u>: Upon final approval, the Policy will be forwarded to Principals and Vice-Principals to provide governance and specific procedure with respect to promoting and supporting positive student behaviour and maintaining a positive school climate.

FINANCIAL IMPACT: The Ministry of Education has committed funds to the in-servicing of Board staff on their obligations under the new safe schools legislative requirements.

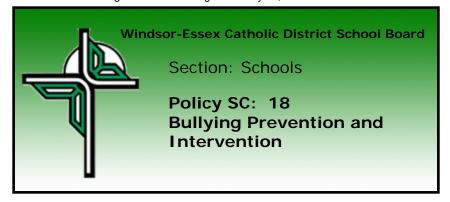

1.0 Objectives



- 1.1 To ensure that the school environment is one of respect, dignity and trust, consistent with the Gospel Values.
- 1.2 To develop and implement comprehensive board-wide bullying prevention strategies.
- 1.3 To develop and implement comprehensive board-wide intervention strategies to address incidents of bullying.
- 1.4 To empower all students and the entire school community to create schools free from bullying.

2.0 Definitions

2.1 **Bullying** is typically a form of repeated, persistent, and aggressive behaviour directed at an individual or individuals that is intended to cause (or should be known to cause) fear and distress and/or harm to another person's body, feelings, self-esteem, or reputation. Bullying occurs in a context where there is a real or perceived power imbalance.

Students may attain or maintain power over others in the school through real or perceived differences. Some areas of difference may be size, strength, age, intelligence, economic status, social status, solidarity of peer group, religion, ethnicity, disability, need for special education, sexual orientation, family circumstances, gender, and race.

Bullying is a dynamic of unhealthy interaction that can take many forms. It can be physical (e.g. hitting, pushing, tripping), verbal (e.g., name calling, mocking, or making sexist, racist, or homophobic comments), or social (e.g., excluding others from a group, spreading gossip or rumours). It may also occur through the use of technology (e.g., spreading rumours, images, or hurtful comments through the use of e-mail, cell phones, test messaging, Internet websites, or other technology).

Children who suffer prolonged victimization through bullying, as well as children who use power and aggression as bullies, may experience a range of psychosocial problems that may extend into adolescence and adulthood.

2.2 **School Climate** is the sum total of all of the personal relationships within a school. When these personal relationships are founded in mutual acceptance and inclusion, and modeled by all, a culture of respect becomes the norm. A positive school climate exists when all members of the school community feel safe, comfortable, and accepted. A positive school climate is a crucial component of bullying prevention.

3.0 Guiding Principles

- 3.1 Bullying behaviours contradict the Gospel values, which are centered in the teachings of Christ. Accordingly the Board believes that all forms of bullying are unacceptable behaviours.
- 3.2 Bullying adversely affects students' ability to learn.
- 3.3 Bullying adversely affects healthy relationships and the school climate.
- 3.4 Bullying adversely affects a school's ability to educate its students.
- 3.5 Bullying will not be accepted on school property, at school-related activities, on school buses, or in any other circumstances (e.g., online) where engaging in bullying will have a negative impact on the school climate.

4.0 Specific Directives

- 4.1 The Board shall ensure that a comprehensive bullying prevention strategy is developed and implemented that includes expectations for appropriate student behaviour.
- 4.2 The Board shall ensure that a comprehensive intervention strategy is developed and implemented to address incidents of bullying, including appropriate and timely responses. Intervention should be done in ways that are consistent with a progressive discipline approach as set out within the Board's Student Discipline Policy.
- 4.3 The Board shall ensure that procedures are developed and implemented that allow students and members of the school community to report incidents of bullying behaviour safely and in a way that will minimize the possibility of reprisal.
- 4.4 Board employees who work directly with students, including administrators, teachers and non-teaching staff (including staff in social work, child and youth work, psychology, and related areas, and educational assistants) must respond to any student behaviour that is likely to have a negative impact on the school climate in accordance with the Student Discipline Policy and Procedure. Such inappropriate behaviour may involve bullying.
- 4.5 Any employee of the board or transportation provider who becomes aware that a student at a school may have engaged in an activity for which suspension or expulsion must be considered, must report the matter to the principal as required and directed within the Student Discipline Policy and Procedure.

- 4.6 The Board shall ensure that support is provided for students who have felt bullied and their parents, members of the school community who have felt bullied, for students who have bullied others, and for students and members of the school community who have been affected by observing bullying.
- 4.7 The Board shall put in place training strategies for all Principals, Vice-Principals, teachers, and non-teaching staff (including staff in social work, child and youth work, psychology, and related areas, and educational assistants). The training strategies must include ways of responding to gender-based and homophobic bullying that are consistent with equity training on cultural sensitivity, on respect for diversity, and on special education needs.
- 4.8 The Board shall actively communicate its policy and procedures on bullying prevention and intervention to students, parents, teachers and other school staff, school councils, volunteers, and school bus operators/drivers. The roles and responsibilities of all members of the school community shall be clearly articulated and understood.

5.0 Responsibility

- 5.1 The administration of the Bullying Prevention and Intervention Policy is the responsibility of the Director of Education or designate(s).
- 5.2 It is the responsibility of trustees, senior administration, principals, vice-principals, supervisors, staff and the school community to foster an environment of respect, dignity and trust.
- 5.3 All policies, procedures, guidelines, and practices of the Board shall promote the principles of bullying prevention.

6.0 Review and Evaluation

- 6.1 Schools shall conduct an analysis of the school climate through surveys of students, staff members, and parents every three years.
- 6.2 Performance indicators shall be utilized for monitoring, reviewing, and evaluating the effectiveness of the Board's Bullying Prevention and Intervention policy and procedures.
- 6.3 This policy shall be reviewed during the 2013 –2014 review cycle.

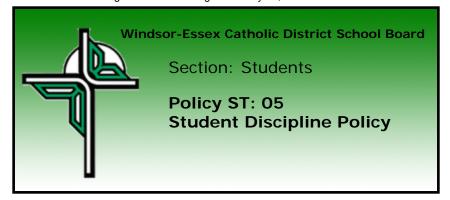

1.0 Objectives



1.1 To meet the goal of creating a safe, caring, and accepting school environment by supporting the use of positive practices as well as consequences for inappropriate behaviour, including progressive discipline, which includes suspension and expulsion where necessary.

2.0 Guiding Principles

- 2.1 The Provincial Code of Conduct, the Windsor-Essex Catholic District School Board Code of Conduct and the *Education Act* create expectations for behaviour for all persons on school property.
- 2.2 It is important that all pupils have a safe, caring and accepting school environment in order to maximize their learning potential and to ensure a positive school climate for all members of the school community.
- 2.3 Pursuant to the *Education Act*, principals are required to maintain proper order and discipline in schools, and pupils are responsible to the principal for their conduct and are required to accept such discipline as would be exercised by a reasonable, kind, firm and judicious parent.
- 2.4 The Board does not support discipline measures that are solely punitive. Schools are encouraged to implement proactive positive practices and corrective supportive practices when necessary.

3.0 Specific Directives

Positive Practices:

3.1 In order to promote and support appropriate and positive pupil behaviours that contribute to creating and sustaining safe, comforting and accepting learning and teaching environments that encourage and support students to reach their full potential, the Board supports the use of positive practices for: (1) prevention, and (2) positive behaviour management.

- 3.2 Preventative practices include:
 - Anti-bullying and violence prevention programs;
 - Mentorship programs;
 - Student success strategies;
 - Catholic Character education;
 - Citizenship development;
 - Student leadership; and
 - Healthy lifestyles.
- 3.3 Positive behaviour management practices include:
 - Program modifications or accommodations;
 - Class placement;
 - Positive encouragement and reinforcement;
 - Individual, peer and group counseling;
 - Conflict resolution;
 - Mentorship programs;
 - Sensitivity programs;
 - Safety Plans;
 - Student Behaviour Support Plans
 - School, Board and community support programs; and
 - Student success strategies;
- 3.4 The Board recognizes that, in some circumstances, positive practices might not be effective or sufficient to address inappropriate pupil behaviour. In such circumstances, the Board supports the use of consequences.
- 3.5 In circumstances where a pupil will receive a consequence for his/her behaviour, it is the expectation of the Board that the principle of progressive discipline, consistent with Ministry of Education direction and PPM 145, will be applied, if appropriate.

Prevention and Awareness Raising:

- In order to promote a positive school climate, the Board must provide opportunities for all members of the school community to increase their knowledge and understanding of such issues as homophobia, gender-based violence, sexual harassment, inappropriate sexual behaviour, critical media literacy, and safe Internet use.
- 3.7 Schools shall conduct anonymous school climate surveys of their students, staff and parents every two years. The surveys must include questions on bullying/harassment related to homophobia, gender-based violence, and sexual harassment. The survey results must be shared with safe schools teams and be used to build strategies into the school improvement plan to improve the school climate.

Reporting and Responding to Incidents:

3.8 Administration shall develop procedures to ensure that all employees of the board who become aware that a student may have engaged in an activity that must be considered for suspension or expulsion under subsection 306 (1) or 310 (1) of the Education Act report the matter to the principal as soon as reasonably possible.

3.9 Board employees who work directly with students – including administrators, teachers, and non-teaching staff (including staff in social work, child and youth work, psychology, and related areas, and educational assistants) – must respond as required under the Education Act and regulations to student behaviour that is likely to have a negative impact on the school climate. Such behaviour includes all inappropriate and disrespectful behaviour at any time at school and at any school-related event if, in the employee's opinion, it is safe to respond to it. Such inappropriate behaviour may involve swearing, homophobic or racial slurs, sexist comments or jokes, graffiti, or vandalism, and behaviour identified under sections 306 and 310 of the Education Act.

Supports for Students:

- 3.10 <u>All employees of the Board must take seriously all allegations of gender-based violence, homophobia, sexual harassment, and inappropriate sexual behaviour, and act in a timely, sensitive, and supportive manner.</u>
- 3.11 Administration shall develop procedures to ensure that principals notify parents of victims of serious student incidents when it is permissible and required under the Education Act and its regulations.

Progressive Discipline:

- 3.12 The goal of this policy, with respect to progressive discipline, is to support a safe learning and teaching environment in which every pupil can reach his or her full potential. Appropriate action must consistently be taken by schools to address behaviours that are contrary to provincial and Board Codes of Conduct. Genderbased violence, sexual harassment, and inappropriate sexual behaviour must be addressed.
- 3.13 Progressive discipline is an approach that makes use of a continuum of interventions, supports, and consequences, building upon strategies that promote positive behaviours. The range of interventions, supports, and consequences used by the Board and all schools must be clear and developmentally appropriate, and must include learning opportunities for pupils in order to reinforce positive behaviours and help pupils make good choices. For pupils with special education and/or disability related needs, interventions, supports and consequences must be consistent with the expectations in the student's IEP and/or his/her demonstrated abilities.
- 3.14 The Board, and school administrators, must consider all mitigating and other factors, as required by the *Education Act* and as set out in Ontario Regulation 472/07.
- 3.15 Progressive discipline may include early and/or ongoing intervention strategies, such as:
 - Contact with the pupil's parent(s)/guardian(s);
 - Verbal reminders;
 - Review of expectations;
 - Written work assignment with a learning component;
 - Volunteer service to the school community;
 - Peer mentoring;

- Referral to counseling;
- Conflict mediation and resolution; and/or
- Consultation.
- 3.16 Progressive discipline may also include a range of interventions, supports and consequences when inappropriate behaviours have occurred, with a focus on improving behaviour, such as one or more of the following:
 - Meeting with the pupil's parent(s)/guardian(s), pupil and principal;
 - Referral to a community agency for anger management or substance abuse counseling;
 - Detentions;
 - Withdrawal of privileges;
 - Withdrawal from class;
 - Restitution for damages;
 - Restorative practices; and/or
 - Transfer
- 3.17 The Board shall not support discipline measures that are solely punitive or use exclusion (section 265 (l) (m) of the Education Act) as a disciplinary measure. If a principal does decide that it is necessary to exclude a student from a school or classroom because the student's presence in the school or classroom would, in the principal's judgment, be detrimental to the physical or mental well-being of the pupils, the principal's actions shall be in accordance with the Education Act and must be consistent with the Human Rights Code. The Principal shall notify the student's parents of the exclusion as soon as possible in the circumstances, and inform them of their right to appeal under clause 265 (l) (m).
- 3.18 When addressing inappropriate behaviour, school staff should consider the particular pupil and circumstances, including any mitigating and other factors as set out in the Student Discipline Procedures, the nature and severity of the behaviour, and the impact on the school climate. Before applying disciplinary measures, the principal/designate and/or Discipline Committee of the Board shall consider the discriminatory impacts of decisions on pupils protected by the Human Rights Code, including but not limited to the impact to those students who may face discrimination based on race and disability, and whether or not accommodation is required.
- 3.19 The Board also supports the use of suspension and expulsion as outlined in Part XIII of the *Education Act* where a pupil has committed one or more of the infractions outlined below on school property, during a school-related activity or event, and/or in circumstances where the infraction has an impact on the school climate.

Suspension:

- 3.20 The infractions for which a suspension may be imposed by the principal include:
 - 1. Uttering a threat to inflict serious bodily harm on another person;
 - 2. Possessing alcohol, illegal and/ or restricted drugs;
 - 3. Being under the influence of alcohol;
 - 4. Swearing at a teacher or at another person in a position of authority;

- 5. Committing an act of vandalism that causes extensive damage to school property at the pupil's school or to property located on the premises of the pupil's school;
- 6. Bullying;
- 7. Any act considered by the principal to be injurious to the moral tone of the school:
- 8. Any act considered by the principal to be injurious to the physical or mental well-being of members of the school community; or
- 9. Any act considered by the principal to be contrary to the Board or school Code of Conduct.
- 3.21 A pupil may be suspended only once for an infraction and may be suspended for a minimum of one (1) school day and a maximum of twenty (20) school days. Any such infractions which a board staff member or transportation provider becomes aware must be reported to the principal or designate in accordance with Board procedures.

Mitigating and Other Factors:

3.22 Before imposing a suspension, the principal, as required by the *Education Act*, must consider any mitigating and other factors as set out in the Student Discipline Procedures. For the purpose of the Student Discipline Procedures, the Board interprets the provisions of the *Education Act* and Regulations in a broad and liberal manner consistent with the *Human Rights Code*.

Expulsion:

- 3.23 The infractions for which a principal may consider recommending to the Board that a pupil be expelled from the pupil's school or from all schools of the Board include:
 - 1. Possessing a weapon, including possessing a firearm;
 - 2. Using a weapon to cause or to threaten bodily harm to another person;
 - 3. Committing physical assault on another person that causes bodily harm requiring treatment by a medical practitioner;
 - 4. Committing sexual assault;
 - 5. Trafficking in weapons, illegal, or restricted drugs;
 - 6. Committing robbery;
 - 7. Giving alcohol to a minor;
 - 8. An act considered by the principal to be significantly injurious to the moral tone of the school and/or to the physical or mental well-being of others;
 - 9. A pattern of behaviour that is so inappropriate that the pupil's continued presence is injurious to the effective learning and/or working environment of others;
 - 10. Activities engaged in by the pupil on or off school property that cause the pupil's continuing presence in the school to create an unacceptable risk to the physical or mental well-being of other person(s) in the school or Board;
 - 11. Activities engaged in by the pupil on or off school property that have caused extensive damage to the property of the Board or to goods that are/were on Board property;
 - 12. The pupil has demonstrated through a pattern of behaviour that s/he has not prospered by the instruction available to him or her and that s/he is persistently

- resistant to making changes in behaviour which would enable him or her to prosper; or
- 13. Any act considered by the principal to be a serious violation of the Board or school Code of Conduct;
- 14. Where a student has no history or discipline or behaviour intervention, or not relevant history, a single act, incident or infraction considered by the principal to be a serious violation of the expectations of student behaviour and/or a serious breach of the Board or school Code of Conduct.

Any such infractions about which a board staff member or transportation provider becomes aware must be reported to the principal or designate in accordance with Board procedures.

Mitigating Factors and Other Factors:

- 3.24 Before imposing a suspension pending an investigation to determine whether to recommend expulsion, the principal must consider any mitigating factors as set out in the Student Discipline Procedures.
- 3.25 If the principal imposes a suspension pending an investigation to determine whether to recommend expulsion, the Principal must consider any mitigating and other factors as set out in the Student Discipline Procedures in determining whether to recommend an expulsion from the pupil's school or from all schools of the Board, as required by the *Education Act*. If the principal determines it is not appropriate to recommend an expulsion, the principal must consider mitigating and other factors in deciding whether to shorten the length of the suspension.
- 3.26 For the purpose of the Student Discipline Procedures, the Board interprets the provisions of the *Education Act* and Regulations in a broad and liberal manner consistent with the *Human Rights Code*.

Principal Investigation:

3.27 Before recommending an expulsion from the pupil's school or from all schools of the Board, the principal must complete an investigation, as required by the *Education Act*, which is consistent with the expectations for principal investigations outlined in the Board's Student Discipline Procedures.

Appeal:

- 3.28 Where a pupil's parent/guardian or the pupil, if 18 or older, or 16 or 17 and has removed him/herself from parental control, disagrees with the decision of a principal to suspend the pupil that pupil's parent/guardian or the pupil, if 18 or older, or 16 or 17 and removed from parental control, may appeal the principal's decision to suspend the pupil, in accordance with the Board's Student Discipline Procedures and Suspension Appeal Guidelines.
- 3.29 Suspension appeals will not be conducted in accordance with or be subject to the *Statutory Powers Procedure Act*.

Superintendent Responsible for Student Discipline:

3.30 The Superintendent Responsible for Student Discipline shall have the powers and duties outlined in the Student Discipline Procedures.

Discipline Committee:

- 3.31 The Board authorizes the creation of two Discipline Committees. Committee "A" shall decide appeals of principal suspensions and principal recommendations for expulsion arising out of county schools. Committee "A" shall be composed of three (3) Trustees elected within the City of Windsor to the WECDSB. Committee "B" shall decide appeals of principal suspensions and principal recommendations for expulsion arising out of schools located in the City of Windsor. Committee "B" shall be composed of three (3) Trustees elected within the County of Essex to the WECDSB. For these purposes, the Discipline Committees will conduct the suspension appeals and expulsion hearings in accordance with the Student Discipline Procedures, Suspension Appeal Guidelines, Expulsion Hearing Guidelines and Rules.
- 3.32 In all cases where consequences might be imposed, teachers, administrators and the Board will consider the safety and dignity of all pupils, and the impact of the activity on the school climate.
- 3.33 The Discipline Committee shall have the powers as set out in the *Education Act* and any other powers to implement any appropriate Order.

Authorization for Creation of Procedures:

3.34 This policy authorizes the creation of procedures for implementation, which shall be considered guidelines pursuant to the *Education Act*.

Review and Development of Programs for Expelled Students and Those on Long-Term Suspension:

- 3.35 Programs for expelled students or for those on a long-term suspension shall be reviewed and developed to allow students an opportunity to continue their education while they are away from their home school. The programs shall address the needs of all students across the jurisdiction equitably. They shall take into account local needs and circumstances such as geographical considerations, demographics, cultural needs and availability of board and community support services.
- 3.36 The programs shall provide an academic component for any student that is serving a suspension of 6 days or more and shall provide an academic and non-academic component to any student that is serving a suspension of 11 days or more, or is on a full expulsion.
- 3.37 The board shall access evidence-based practices that promote positive student behaviour.

- 3.38 A Student Action Plan shall be developed for every student who makes a commitment to attend a board program for suspended students or a program for expelled students (as applicable).
- 3.39 The program will maintain a comprehensive and on-going connection with the home school and provide for parental/guardian involvement whenever possible.

Delegation of Authority Regarding Discipline

3.40 A principal may delegate some disciplinary responsibilities to a vice-principal and/or teacher of the school in accordance with the Education Act, Ministry of Education policies, and Board policies/procedures.

School-Level Plans

3.41 All schools must develop and implement a school-wide progressive discipline plan.

The plan must be consistent with legislation, Ministry guidelines, and Board policy and procedure.

4.0 Responsibility

- 4.1 The Director of Education shall be responsible for the implementation of this policy.
- 4.2 The Director shall put in place a training strategy on the Board's Student Discipline policy for all administrators, teachers, and non-teaching staff, and shall work with the Windsor-Essex County Children's Aid Society to develop and implement annual training for Board staff concerning their duty to report under the Child and Family Services Act.

5.0 Review and Evaluation

- 5.1 The programs for students under long-term suspension and for expelled students shall be monitored, reviewed and evaluated for effectiveness on an annual basis.
- 5.2 Schools should address gender-based violence, homophobia, sexual harassment, and inappropriate behaviour in their school improvement plans and shall evaluate the effectiveness of their safe schools policies and programs through the use of school climate surveys, which must be undertaken at least every two years. The results of the surveys must be shared with the schools' Safe Schools Teams.
- 5.3 This policy shall be reviewed during the 2013–2014 policy review cycle.

RECOMMENDATION:

PRESENTED FOR:

That the Board approve payment in the amount of \$570.24, including PST, to Industrial Alliance Pacific Insurance and Financial Services Inc. for the Trustee Group Accident Insurance, including Student Trustees, for the year 2010.

SYNOPSIS:

The Board provides accident insurance for all Trustees, including Student Trustees, and it is now time to renew the coverage for 2010.

BACKGROUND COMMENTS:

The Trustee Group Accident Insurance Policy from Industrial Alliance Pacific Insurance and Financial Services Inc. is due for renewal on January 1, 2010. The policy provides coverage for an injury sustained while performing the duties of a Trustee away from the Trustee's residence or place of regular employment and while traveling on business for the Board. A summary of coverage is provided in Appendix A.

FINANCIAL IMPLICATIONS:

The premium of \$570.24, including PST, for 2010 remains unchanged from 2007, 2008 and 2009. Notwithstanding the unchanged premium, enhancements and adjustments to coverages have been made from the prior year as identified in Appendix A.

TIMELINES:

The renewal is due on January 1, 2010 and provides coverage for one year up to December 31, 2010.

11. **Report from Chair**

- Trustee Soulliere requested that any correspondence received by the Chair be scanned and sent to all SEAC members. This is to become practice from this date forward.
- Trustee Soulliere informed members of Bev Clarke's resignation from SEAC. Bev was Chairperson of SEAC and represented the Learning Disabilities Association of Ontario for Windsor-Essex. We will miss her source of information and input on the Committee.

12. **Report from Trustees**

• Trustee DiMenna reported that our city schools will implement full day every other day JK/SK, effective September 2010. This will be reflective of the current JK-SK model in the county. As well, as mandated by the Ministry at the recommendation of Dr. Pascal, full day JK/SK will be phased in for 14 various school classrooms in September 2010. Correspondence will go out to parents regarding all of these implementations.

13. **Report from Superintendent**

- Superintendent Geml advised the committee that Trustee Mary DiMenna was voted Vice-Chair of the Board at the Organizational Board Meeting on Tuesday, December 1, 2009.
- Superintendent Geml reported that at the annual meeting with Thames Valley, the School Support Program submitted a yearly report to the Board for both 2008 and 2009. Cathy reported to the Committee and advised of the changed mandate, whereby Thames Valley personnel work in schools with teachers, training and consulting. This has resulted in teacher training almost doubling, which is a tremendous advantage for our students. The 2009-2010 school year should be much the same, with similar or better results expected. There is a transition piece on Autism for all students coming soon.
- The Regional Special Education Council sited our Board as utilizing best practices in their report at the RSEC symposium.
- We are a lead Board for the Learning for All K-12 and working on a pilot for the draft resource document. As such, we require input from both elementary and secondary staff. There will be more input at the next meeting in January.
- Accessibility for Ontarians has been introduced to schools and businesses.
 This involves parents or others with disabilities visiting the school. They
 must advise the school of the accommodations required. We are working on
 a draft protocol, which should be ready by January. It will go to the Board
 and we hope to in-service Principals sometime in January.
- Superintendent Geml reported on a new project from the Council of Directors of Education (CODE) whereby funding was supplied to involve JK

 Grade 1 in Assessment and Intervention. CODE has asked us to work on a regional assessment plan using best practices in our system for this age and grade level. We have utilized PALS, expanded on that base and sent in the plan for approval. We will elaborate and update SEAC in January.
- Superintendent Geml reported on the IEP Review Session we participated in on November 24 in London. The focus is on parental concerns, proof of consultation and outcomes. Our internal review process involves working

- school by school with check lists to make sure we get to every student with an IEP. There were personnel from eight Boards at the review, who completed check lists and discussed components of the IEP. The parent representative from our Board was pleased with the outcome and encourages student independence along with alignment with the Ministry and ownership by the teachers for those children involved. The IEP guide book is being updated and policy around the process is being discussed for implementation.
- Superintendent Geml reported on the joint SEAC meeting with the GECDSB on November 26. The presentation by Dr. Mary Broga on mental health and the Windsor Regional Hospital was very worthwhile and informative. Pam Skillings and Heather Liffiton reported on the Student Support Leadership Initiative (SSLI). They advised that Valerie Pringle will be the keynote speaker along with Dr. Len Cortese for the two-day forum during Canadian Mental Health Week on May 6 and 7.
- Superintendent Geml advised the Committee of the realignment of the Board to meet the Ministry's mandate to align learning, JK to Gr. 12. This has resulted in some changes to personnel and portfolios.
- Parents want to see a more seamless alignment with no disconnect in curriculum and special education. The Learning Support Services Department will now be called Student Achievement JK-12. Superintendent Geml will oversee curriculum and special education and the gradual alignment of student success (June 2010).
- Superintendent Staudt will oversee Research and Data Management to support student achievement.

15. **Association Reports**

- Sonia Sovran, representative from the LDAO gave an update on Math Pals sessions, which are finished now until the new year. The program has been successful not only in terms of academics, but also for increasing self-esteem and empowerment of the students involved. She feels the attitude toward math has also changed to one that is more positive.
- The LDAO was asked through the Parent Association Advisory Committee on SEAC to send out a feedback form regarding IEPs and the IPRC process. This was completed by SEAC representatives and LDAO chapters. The responses are being collated and are to be presented to the Ministry of Education.
- Sonia reported that there is a free online workshop called *IEP 101 for Parents and Students* on the LDAO website. The website is **Idaolearning.ca**.
