It was suggested that the speaker be part of the Summer Institute. Topics will be investigated through Superintendents Shea and Byrne.

  - As the due date for submissions is May 13, it was decided that there was not enough time to get a regional grant proposal submitted. The suggestion was made that for next year, the Parent Involvement committee begin the dialogue for projects early in the school year, making sure to meet criteria for the grant and submitting well within timelines. Discussion of topics included brochures for grade eight transition to secondary school, financial literacy and curriculum for students in both elementary and secondary, parents setting aside funding for post-secondary education.
  - The committee members are hopeful that individual schools are presenting and submitting to the Ministry proposals for the PRO grants for up to \$1000 per school.
